Sir,

As per the provision of section 65 (4) of Maharashtra University of Health Sciences Act-1998, I am directed to inform you that, on the basis of the Local Inquiry Committee report and the power conferred on Hon'ble Vice Chancellor by the Academic Council vide Resolution No. 68/2018 in its meeting held on 18/06/2018, the Hon'ble Vice Chancellor is pleased to grant First Time Affiliation to your College, viz. "Mauli Nursing College, At. Post. Hatta, Tal. Basmal, Dist. Hingoli" for B.Sc Nursing Course for the academic year 2018-19. However, this affiliation is subject to the following conditions:-

- 1) The intake capacity shall be 60 students for B.Sc Nursing Course.
- 2) Rules and Regulations made by Indian Nursing Council, New Delhi, Govt. of Maharashtra and the University, as amended from time to time, will be binding on the College.
- 3) The college should obtain approval for teachers from Maharashtra University of Health Sciences, Nashik
- 4) This First Time Affiliation is Valid for Academic year 2018-19 only.
- 5) The next batch of students shall not be admitted unless continuation of affiliation from the University is obtained by the college.
- 6) Compliance of following deficiencies within 3 months from the date of issuance of this letter: -
  - i) Internal work of construction to be completed.
  - ii) Approval of teaching Staff shall be obtain.
- 7) The College shall upgrade the infrastructure, clinical and other facilities within a period 3 years as per the Minimum Standard Requirement approved by the Govt. of Maharashtra vide its letter dtd. 14/06/2018.
